## **Protective Equipment Situation and Penalty Matrix**

During the pre-game warm-up, player fails to wear protective equipment or wears protective equipment improperly (i.e. Not worn or fastened as intended by Hockey Canada and/or the manufacturer). Player on the player's or penalty bench fails to wear protective equipment or wears protective equipment improperly (i.e., Not worn or fastened as intended by Hockey Canada and/or the manufacturer).	1 <sup>st</sup> offence = Team warning; Minors for Illegal Equipment issued thereafter. Protective equipment worn is <b>not</b> <b>certified</b> (by CSA or BNQ) <b>or is</b> <b>modified, incomplete or damaged</b> . Examples: Equipment is modified; Straps or fasteners missing or ear pieces missing; Structural damage evident.	Minor penalty for Illegal Equipment. Protective equipment <b>worn</b> <b>improperly</b> (i.e. Not worn as intended by Hockey Canada and/or the manufacturer) while <b>on the ice</b> <b>during play.</b> Examples: Helmet or visor worn in a tilted/offset manner; Mouth guard not worn over the teeth; Throat protector too low/not actually covering throat.	1 <sup>st</sup> offence = Team warning; Misconducts issued thereafter.
