Founded in 1911, the GTHL is a non-profit organization and is the largest amateur minor hockey league in the world. The GTHL registers more than 40,000 annual participants in Markham, Mississauga, Toronto and Vaughan. The GTHL celebrated its 100th season in 2011-12.

Reporting

Reporting to the Coordinator-Officiating Development, the GTHL Officiating Technical Director is responsible for providing leadership within the areas of Hockey Canada's, the Ontario Hockey Federation's, and the GTHL's officiating programs. The TD will play an important role assisting the GTHL in the development and evaluation of officiating clinics, clinic materials, outreach & retention programs, and instructional staff.

Duties & Responsibilities:

- Maintain and provide an expert level knowledge of the playing rules and officiating duties, and of HCOP procedures and positioning systems
- Provide league management and administrators with technical information and advice about the playing rules and officiating
- Maintain an expert level of knowledge and skill in education and instructional techniques
- Liaise closely with the managers of game officials (or equivalent) with the various leagues and associations within the GTHL to determine the HCOP qualification and development needs of their game officials
- Create officiating development programs for GTHL game officials, supervisors of officials, and HCOP clinic instructors



- Evaluate the effectiveness of the GTHL officiating development program
- Liaise with the GTHL Coordinator-Officiating to ensure that officiating development programming is delivered effectively and efficiently
- Produce GTHL officiating development program curricula and training materials using computer software
- Ensure that the GTHL Officiating Program Officiating Development Manual accurately reflects relevant development program information and policies
- Define the GTHL officiating development program training standards, officiating performance standards, and level upgrade process
- Manage the CSHO Referee School
- Manage the assignments of GTHL officiating program HCOP clinic instructors
- Oversee the selection process and nomination of GTHL officials for development and training events/opportunities conducted at the branch, regional or national level
- Assist the GTHL in representation when necessary at Hockey Canada, OHF, or GTHL Meetings/events and committees

Qualifications and Experience:

- Extensive experience and knowledge of officiating within the Hockey Canada structure
- Minimum 5 years of experience instructing HCOP clinics
- Knowledge of Hockey Canada Coaching Development Programs
- Knowledge of the Hockey Canada and Greater Toronto Hockey League officiating rules and GTHL rules, regulations, policies, programs
- Working knowledge of Microsoft Office; Word, PowerPoint, Excel
- Previous facilitating experience and/or previous teaching considered an asset
- Experience working within a sports organization, especially hockey, would be considered an asset
- Ability to work in a team environment and lead a committee of volunteers and paid instructor staff
- Exceptional customer service skills
